Guidelines for Open Burning

Pleasantveiw follows Ordinance 15-0-1 Guidelines. Prohibited Open Burning: Open burning that is offensive or objectionable because of smoke or odor emissions or when atmospheric conditions or local circumstances make such fires hazardous shall be prohibited. Recreational fires shall not be conducted within 25 feet of a structure or combustible material and must be constantly attended. All jurisdictions do not allow leaves or refuse burning with the exception of unincorporated Cook County (see below).
Prairie & ecological landscape burns need an EPA permit and must follow EPA rules and regulations.
